This workshop is an opportunity for the public to ask questions and offer opinions regarding important policy issues shaping the implementation of the Cuyama Basin Groundwater Sustainability Plan.

Topics to be presented will include:

- Groundwater monitoring networks and proposed improvements.
- Criteria for evaluating groundwater sustainability.
- Approach for groundwater pumping allocations.

The CBGSA is tasked with achieving groundwater sustainability in the Cuyama Basin by 2040 through implementation of the amended Groundwater Sustainability Plan that was submitted in 2022 and approved by the California Department of Water Resources.
