**NATURE OF PROCEEDINGS:** Trial Setting Conference

The matter is called for hearing.

Discovery stay is lifted so the parties may conduct discovery for the limited purpose of the Phase 1 Basin boundary.

The parties must file and serve a [Proposed] Discovery Plan by 11/18/2022. Discovery Plan must address experts, and confirm that the adjudication concerns groundwater and not surface waters. (Even though impact upon surface waters may be part of the evidence presented at trial, the court will not be adjudicating surface waters).

Any party may file a Motion to Compel Further Responses to Initial Disclosures, if necessary, by calling the Court for a hearing date prior to filing and serving the motion.
