16 The Application by Plaintiffs, Bolthouse Land Company, LLC, Wm. Bolthouse Farms,
17 Inc., Grimmway Enterprises, Inc., Diamond Farming Company, Lapis Land Company, LLC, and
18 Ruby Land Company, LLC (collectively "Plaintiffs") for Service by Publication (Application)
19 was filed on June 12, 2023.

20 The Court, having read and considered the Application, and good cause appearing
21 therefore:

22 **HEREBY FINDS AND ORDERS that:**

- 23 1. That Plaintiffs have exercised reasonable diligence to complete service as required by
24 Code of Civil Procedure section 836 but have not been able to serve all landowners within
25 the Basin via United States Mail, return receipt requested.
- 26 2. Pursuant to Code of Civil Procedure section 436, subdivision (i), and the Court's inherent
27 powers, the Court has the authority to authorize any other procedures it finds appropriate
28 and necessary to provide notice to persons who may hold groundwater rights in the Basin.
3. The Court finds that service by posting would not be the most effective and would not
provide best notice under the circumstances for the landowners identified on Exhibit "A"
to the Declaration of Robert G. Kuhs in support of Plaintiffs' Application.
4. That Plaintiffs are hereby authorized and directed to serve the Notice of Commencement
of Groundwater Adjudication (**Notice of Commencement**), Form Answer to First
Amended Complaint and First Amended Complaint upon defendants identified on Exhibit

1 A attached hereto, by publication made at least once a week for four successive weeks as
2 follows:

- 3 a. Those landowners identified in Exhibit A as owning property located in Kern
4 County shall be served by publication in the Bakersfield Californian, a
5 newspaper of general circulation in Kern County.
- 6 b. Those landowners identified in Exhibit A as owning property located in San
7 Luis Obispo County shall be served by publication in the SLO Tribune, a
8 newspaper of general circulation in San Luis Obispo County.
- 9 c. Those landowners identified in Exhibit A as owning property located in
10 Ventura County shall be served by publication in the Ventura County Star, a
11 newspaper of general circulation in the Ventura County.
- 12 d. Those landowners identified in Exhibit A as owning property located in Santa
13 Barbara County shall be served by publication in the Santa Barbara News
14 Press a newspaper of general circulation in Santa Barbara County.
- 15 e. All landowners identified in Exhibit A shall also be served by publication in
16 the Daily Report, a newspaper of general circulation in Kern County, San Luis
17 Obispo County, Ventura County, and Santa Barbara County.

18 5. Plaintiffs shall forthwith deposit an envelope containing the Notice of Commencement,
19 the Court approved Form Answer, and the First Amendment Complaint with the United
20 States Post Office, postage prepaid, directed to each landowner shown on Exhibit A, to the
21 mailing address shown on the latest equalized assessment roll for each of the Counties. A
22 declaration of this mailing, or of the fact that the address was not ascertained, must be
23 filed with the Court upon completion of publication and mailing as authorized and ordered
24 herein.
