13 On August 7, 2023, the parties appeared for the first day of the Phase One trial (**Phase One**)
14 concerning the challenge to the DWR Bulletin 118 Basin Boundary for the Cuyama Groundwater
15 Basin (**Basin**) by Defendants Highland Vineyards et al. and Ventucopa Landowners.

16 On Friday, August 4, 2023, Defendant Walking U Ranch filed an Ex Parte Application to
17 Continue Trial (**Ex Parte**) based upon the status of service. Following oral argument on August 7,
18 2023, the Court granted the Ex Parte to continue the trial date. All parties agreed that the continuance
19 should not reopen discovery, pre-trial rulings and other pre-trial proceedings and that status quo should
20 be maintained pending trial.

21 On August 8, 2023, the Court issued a Minute Order granting the Ex Parte and continuing the
22 trial date and directing the parties to meet and confer and to submit a formal proposed order concerning
23 the Court's continuance of trial and a proposed date for a status conference. On August 11, 2023, the
24 parties participating in the Phase One Trial met and conferred regarding timing to complete service,
25 and availability of counsel and experts for trial. As a part of the meet and confer efforts the Plaintiffs
26 agreed to proceed with posting unserved landowners pursuant to *Code of Civil Procedure* section
27 836(d)(1)(C). Based upon the forgoing, the parties respectfully request the Court enter the order
28 below.



1 **ORDER**

2 **GOOD CAUSE APPEARING, the Court orders as follows:**

- 3 1. Walking U Ranch’s Ex Parte Application to continue the trial is granted.
- 4 2. The Phase One trial is continued to **January 8, 2024**, commencing at 10:00 a.m., in
5 Department 9 with pending requests for judicial notice and opening statements,
6 resuming on January 9, 2023 at 10:00 am with the testimony of Objecting Party expert
7 Anthony Brown.
- 8 3. The Court’s Order Re Phase One Discovery and Trial Order remains in effect and
9 unchanged. Discovery remains closed. The Court’s pretrial rulings, including rulings
10 on Motions in Limine and Supporting Parties’ Application for a Protective Order,
11 remain in effect. With the exception of the new trial date, this Order does not modify
12 or amend the Minute Order, dated August 8, 2023.
- 13 4. Plaintiffs shall proceed with service by publication as set forth in the Amended Order
14 on Plaintiffs’ Renewed Application for Service by Publication, a copy of which is
15 attached to this Order as Exhibit 1.
- 16 5. Plaintiffs will proceed with posting unserved landowners’ properties pursuant to *Code*
17 *of Civil Procedure* section 836(d)(1)(C), and file proofs of service when complete.
- 18 6. A status conference regarding the status of service is set for ~~Thursday, October 12,~~
19 ~~2023~~, at ~~_____ in the afternoon or~~ Wednesday, October 11, 2023, at 10:00 a.m.
20 Plaintiffs will submit a status report regarding service by October 5, 2023.
- 21 7. The court schedules a non-appearance case review for **August 21, 2023, at 8:30 am**,
22 to check whether this order has been submitted to the Court.

10 On June 20, 2023 the Court granted Plaintiffs Bolthouse Land Company, LLC, Wm. Bolthouse
11 Farms, Inc., Grimmway Enterprises, Inc., Diamond Farming Company, Lapis Land Company, LLC, and
12 Ruby Land Company, LLC's (collectively **Plaintiffs**) Renewed Application for Service by Publication
13 (**Application**) and entered an Order on Plaintiffs' Renewed Application for Service by Publication
14 ("Order"). Following continuance of the Phase One trial Plaintiffs request that the Court amend the order
15 to substitute the Santa Barbara Independent for the Santa Barbara Valley Press as a paper of general
