On August 7, 2023, the parties appeared for the first day of the Phase One trial (**Phase One**) concerning the challenge to the DWR Bulletin 118 Basin Boundary for the Cuyama Groundwater Basin (**Basin**) by Defendants Highland Vineyards et al. and Ventucopa Landowners.

On Friday, August 4, 2023, Defendant Walking U Ranch filed an Ex Parte Application to Continue Trial (**Ex Parte**) based upon the status of service. Following oral argument on August 7, 2023, the Court granted the Ex Parte to continue the trial date. All parties agreed that the continuance should not reopen discovery, pre-trial rulings and other pre-trial proceedings and that status quo should be maintained pending trial.

On August 8, 2023, the Court issued a Minute Order granting the Ex Parte and continuing the trial date and directing the parties to meet and confer and to submit a formal proposed order concerning the Court's continuance of trial and a proposed date for a status conference. On August 11, 2023, the parties participating in the Phase One Trial met and conferred regarding timing to complete service, and availability of counsel and experts for trial. As a part of the meet and confer efforts the Plaintiffs agreed to proceed with posting unserved landowners pursuant to *Code of Civil Procedure* section 836(d)(1)(C). Based upon the forgoing, the parties respectfully request the Court enter the order below.
